

SUMMARY ANNUAL REPORT

For Lafayette Venetian Blind, Inc. 401(k) Ret Savings Plan

This is a summary of the annual report for Lafayette Venetian Blind, Inc. 401(k) Ret Savings Plan, EIN 35-1449682, Plan No. 001, for period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$784,389. These expenses included \$99,800 in administrative expenses, \$669,270 in benefits paid to participants and beneficiaries, and \$15,319 in other expenses. A total of 439 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$24,425,104 as of December 31, 2022, compared to \$28,716,430 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$4,291,326. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$3,506,937), including employer contributions of \$271,326, employee contributions of \$784,877, earnings from investments of (\$3,006,325), and other income of (\$1,556,815).
