We are very excited about all the possibilities which will exist for Children's TherAplay to serve the whole family unit more holistically in this new space.

# **2022 IMPACT REPORT**





2022 was another year of tremendous growth, and we knew it was time to start serving our kiddo families more holistically. We expanded our parent education series to offer presentations from therapists on topics of interest to our families, and we included childcare onsite for their convenience.

Our Trauma-Informed Care Specialist began serving more kiddos with adverse childhood experiences, and in June 2022 we piloted our first Trauma-Informed Care Camp in partnership with Bronchos Have Heart in Lafayette, IN.

In December 2022, we enhanced our capacity-building program, and began plans to offer Therapeutic Animal-Assisted Groundwork (TAAG) sessions, which allow 80 more children each week to access the movement of a horse in their treatment plan.

We invested in our staff by spending \$4,122 on continuing education for individual staff members and \$16,310 for all-staff trainings. These trainings included American Hippotherapy Association classes, staff retreats, and leadership trainings.

#### Diversity, Equity + Inclusion Initiatives

- Piloted our first **Trauma-Informed Care Camp**, which welcomed 40 students from diverse backgrounds to experience our environment.
- Created a Transportation Program to disperse gas and ride-share cards to families experiencing transportation barriers.
- Created a more inclusive event experience by providing access decking for individuals in wheelchairs to navigate our sand footing in the arena.
- For the second year in a row, Our Scholarship Fund distributed \$15,000 in financial aid to families. We awarded 100% of financial requests received.



### **Community Outreach**


We also connected with our community. We had 81 physicians in the greater Indianapolis community refer children for therapy services. Our therapists hosted educational in-services for parents and staff on topics like caregiver mental health, service animals, communication devices, and developmental floor time.

Further, in Fall 2022 we hosted the American Hippotherapy Association Level II Clinic, which welcomed 16 therapists from across the country into our facility to sharpen their skills and learn best practices in the field. We also had a record number of active volunteers and volunteer hours logged. Community support continues to help Children's TherAplay thrive!

# **VOLUNTEERS**

### The Value of Volunteers

### **Sidewalking**

Sidewalking is our biggest volunteer need--we require at least 10 volunteer sidewalkers every day! Sidewalkers walk alongside the horse during a therapy session and assist the therapist by providing support and ensuring client safety.

### **Event Support**

Individuals join planning committees or volunteer to set-up, tear-down, or run a station at any of our signature fundraising events throughout the year.

### Weekend Barn Support

Individuals help on weekend mornings to assist our barn staff care for the herd. These volunteers replenish shavings, dump and fill water buckets, help with turn-out, and perform light stall work.

### **Special Projects**

Everyone is welcome! We host groups of up to 10 people throughout the year, or pick a time with your co-workers for your team to rotate coming in to volunteer.

# **MEET KIDDO LUKE**

Kiddo Ambassador Luke is a fun-loving, playful, goofy kid who is always looking to make others laugh. He has a big imagination, and loves to play outdoors with his two older siblings and be with his family. Above all else? Luke is simply a kind and grateful little boy.

"No matter what Luke accomplishes or not, something I'm very proud of is just what a kind person he is," Mom said. "He will go out of his way to share with people or make people feel included. Honestly, he would give you his shirt if you needed it!"

Luke's Mom knew he would need some early intervention therapy, and began seeking out therapy options. After spending lots of hours in and out of traditional medical offices, Mom started seeking out something that might seem a bit more fun for Luke.

"As a kiddo who has been brought to therapy his whole life, he's brought to a lot of sterile, clinic settings. He was constantly going back with all different people into these small rooms, and asked to do all this hard stuff," Mom said. "I was looking for something that felt a little more like being a kid. [Children's] TherAplay felt like a great place to add something more."

Luke's Mom was familiar with horses and thought TherAplay could be a great place to fill Luke's sensory bucket. Once Luke began hippotherapy, the benefits were obvious.

"I saw the benefits of how much riding the horse tapped into his ability to grow in the clinic session," Mom said. "It really reinforced how important it was to have both hippotherapy and the clinical therapy working side by side because it helped him actually access a lot of his tools that were harder for him to access without being able to have that sensory regulation prior to going back to the clinic."



Over the next year as a Kiddo Ambassador, Mom says they have big goals in physical and speech therapy. And although Luke might face challenges, he does so with gratitude.

"I think it's just good for him and his own spirit that that's the way he sees life, is that there's so much to be grateful for," Mom said. "That's just how he looks at things."
