Job Description – Pediatric Speech-Language Pathologist PRN Maternity Leave

TITLE:	PRN Pediatric Speech-Language Pathologist
STATUS:	PRN, per diem for Maternity Leave
EMPLOYMENT TYPE:	Hourly Contract
REPORTS TO:	Director of Therapy Services
GENERAL FUNCTION:	The PRN Speech-Language Pathologist is responsible for evaluating, treating and discharging assigned patients as appropriate and per established policies and procedures; ensuring effective development and application of speech therapy programs and treatment procedures; ensuring optimal assigned patient scheduling and wait list management, satisfaction and appropriate insurance billing and coding.
REQUIRED EXPERIENCE:	The candidate must have a current or pending IN state professional license in Speech-Language Pathology. Pediatric experience is preferred, but not required.
REQUIRED EDUCATION:	Master's degree in Speech-Language Pathology from an accredited program
CERTIFICATIONS:	Maintain ASHA Clinical Certificate of Competence (CCC), CPR/First Aid Certification, and Professional Malpractice Insurance – minimum level: \$1,000,000 each occurrence/\$3,000,000 aggregate.

A DAY IN THE LIFE OF A SPEECH-LANGUAGE PATHOLOGIST AT CHILDREN'S THERAPLAY:

- The PRN SLP position works closely with our physical and occupational therapists to ensure quality outcomes. Each session consists of time spent in our newly remodeled clinic as well as time spent utilizing the movement of the horse as a treatment tool.
- This position will be every Monday from 9:00am-6:30pm starting October 7, 2024, through February 3, 2025. The start and end dates may be adjusted due to unforeseen circumstances.
- You will be part of a collaborative team that continuously strives to improve our skills and education. Monthly you will be provided with a two-hour team meeting receiving education and round tables to

discuss complex cases.

- Ongoing, intentional efforts are being made to ensure we are a diverse, inclusive, and equitable workplace where everyone belongs through third party collaborations and internal efforts.

ESSENTIAL PRIMARY DUTIES OF SPEECH-LANGUAGE PATHOLOGIST:

- Evaluate, treat, and discharge assigned patients as appropriate.
- Maintain timely and quality patient documentation in accordance with TherAplay's best practices.
- Confer with the entire care team to plan and implement effective care plans.
- Always maintain patient confidentiality, conforming to HIPAA privacy regulations.
- Other duties as assigned.

PREREQUISITE SKILLS:

- Knowledge of Medicaid and private insurance plans.
- Familiarity with a variety of speech, language, fluency, voice, and cognitive disorders.
- Experience or training with Alternative and Augmentative Communication (AAC) systems.
- Intermediate pediatric feeding experience strongly preferred.
- Strong interpersonal and communication skills.
- Ability to work collaboratively with a multi-disciplinary team (PT & OT).
- Basic computer literacy.
- Ability to comply with all regulatory standards.
- Must have working knowledge of the rehabilitation field and therapy professions.
- Ability to effectively provide customer service to all customers and contacts.
- Ability to communicate openly, honestly, directly, and effectively with all customers by both written and verbal skills.
- Ability to incorporate a basic understanding of human behaviors, developmental needs, physical needs, emotional needs, and comfort during all interactions.
- American Hippotherapy Association Level I and Level II preferred but not required.

PHYSICAL/ENVIRONMENTAL REQUIREMENTS:

- Ability to lift 50 pounds overhead.
- Ability to walk up to 10 miles per day.
- Ability to work around horses.
- Ability to sustain frequent: standing, walking, bending (forward and sideways), grasping, twisting at the waist, squatting, kneeling
