We all continue to feel so grateful to work for our mission that does so much good for so many families.

There is no contest for my favorite memory from 2023! A star was born, when TherAplay kiddo Mila stepped out of her comfort zone and joined me onstage at our Hoe Down as our first ever kiddo co-host. And let me tell you...she nailed it! At 6 (and a half), Mila showed confidence, poise, and purpose as she shared her TherAplay story with over 600 guests. She was a remarkable witness to the work we do here on a daily basis to empower children to believe they can do hard things and give them the tools they

need to live their dreams!

Our 2023 Hoe Down had another memorable moment when our Founder, Wm. Craig Dobbs, announced that he had secured the funding

needed for our new Dobbs and Towriss Community Engagement Center, which will break ground in the Spring of 2024! This new space will allow us to provide families and community members the opportunity to further connect with Children's TherAplay. Whether it's educational workshops, support groups, social gatherings, or specialized camps, this new space will help us support families raising a child with a disability more holistically. We will also expand our physical therapy space to increase programming and serve more children each year.

The addition of The Dobbs and Towriss Community Engagement Center will mark the completion of our three-phase capital project that began in 2017 with the building of our new barn. We are so grateful to the community of donors who have made our beautiful new barn, clinic, administrative office, and community engagement center possible. Because of all of you, we have increased the number of children and families we serve by 68% in the last 10 years, and we have set our sights on raising that number even higher.

Children's TherAplay brings hope to families who face challenges and uncertainty on a daily basis. We bring laughter and triumph in a safe and caring environment to kids who deserve the opportunity to work alongside someone who believes in them. And I can assure you...we ALL believe!

2023 IMPACT REPORT



2023 was another year for reaching new heights and expanding our services to the families and communities we serve. Not only did we provide more occupational, physical, and speech therapy services to a growing number of kiddos, but we saw an increase in community involvement as well. In 2023, we had more first time and returning donors, a higher donor retention rate, over 100 additional active volunteers, and we attended over 25 community events.

In March 2023, we welcomed two miniature horses, Peanut and Banana, growing our herd and further developing our Therapeutic Animal Assisted Groundwork (TAAG) sessions. With help from Peanut and Banana, we provided over 1,050 TAAG sessions, giving kiddos new opportunities to work on their therapy goals.


Diversity, Equity, + Inclusion Initiatives

- Hosted our first Trauma-Informed Care Camp on site, which welcomed 15 kiddos from diverse backgrounds to experience our fun farm environment.
- Our Transportation Program distributed \$450 in gas and ride share cards to families experiencing transportation barriers.
- Partnered with ProAct Indy, a community engagement and critical service learning organization, to implement a DEI strategic plan that targets areas of need.
- For the third year in a row, Our Scholarship Fund distributed over \$15,000 in financial aid to families. We awarded 100% of financial requests received.

Community Outreach

We also connected with our community. We worked with 158 physicians in the greater Indianapolis community to connect families to our services. Our therapists hosted and coordinated educational in-services for parents and staff on topics like sensory processing and integration, advocating for children in schools, and securing the future of dependents with disabilities.

Further, in Fall 2023 we hosted the American Hippotherapy Association Level II Clinic, which welcomed 16 therapists from across the country into our facility to sharpen their skills and learn best practices in the field. Community support continues to help Children's TherAplay thrive!




Common Diagnoses Served* *Based on Primary and Secondary Diagnoses

Sidewalking

Sidewalking is our biggest volunteer need--we require at least 10 volunteer sidewalkers every day! Sidewalkers walk alongside the horse during a therapy session and assist the therapist by providing support and ensuring client safety.

Event Support

Individuals join planning committees or volunteer to set-up, tear-down, or run a station at any of our signature fundraising events throughout the year.



Individuals help to assist our barn staff care for the herd. These volunteers replenish shavings, dump and fill water buckets, help with turn-out, and perform light stall work.

TAAG

Individuals help run our Therapeutic Animal Assisted Groundwork. These trained volunteers assist kiddos and therapists work on therapy goals off the horse by practicing grooming, leading, and other skills.

MEET KIDDO ZOË

Kiddo Zoë is a silly, sassy, and kind kid who likes to laugh and play. Zoë is an active kiddo who is always doing flips, and cartwheels, and likes to dance with mom! She also loves the outdoors and being in the sun, sand, and dirt. Above all else, Zoë is a fun-loving kiddo who is also sweet and loving to those around her.

"Her two favorite movies in the world are Moana and Because of Winn Dixie, she can watch them two or three times a day!" Mom said. "She is a person of order and I love that about her; she has a spot for all her things. She likes bubbles, cake pops, chocolate, and loves books - we read a lot. Zoë is so diverse!"

In early 2021, Zoë was diagnosed with autism spectrum disorder, sensory processing disorder, global cognitive delay, and bilateral conductive

hearing loss. She was in First Steps and went through a number of occupational and speech therapists before seeking other programs. Eventually, Mom was recommended and introduced to TherAplay.

"We joined TherAplay in 2022 and I have loved it ever since. I am a big lover of horses anyway, so when I heard they get to ride horses during OT I said 'Yeah! Let's do that!" Mom said. "That was the big draw, but I had also heard about TherAplay from more than one person. When you hear good things like that you think 'ok this is probably a good place for my child' and she loves it!"

When Mom started this journey with Zoë she was very protective and found that it took a lot to make her voice heard for Zoë's needs. Her time at TherAplay, however, has provided a flexible environment to work with Zoë as a person rather than a diagnosis.

"The therapists have been so loving and flexible and willing to learn about Zoë as a person. What makes TherAplay unique is that it is very personcentered instead of diagnosis-centered," Mom said. Since coming to TherAplay Zoë "can tend to task a lot longer and her eye contact has improved. I can see that her confidence level with her words is better, she used to whisper but now she is starting to say her words out loud."

Zoë has big goals in occupational and speech therapy. She continues to work hard at Children's TherAplay and grows in her goals each week.

"This is the one place that I bring her for services and I know she's happy," Mom said. "She is always so excited to come here!"
